Abstract

This case study explores the effectiveness of individualized homeopathic medicine in managing *Acne Rosacea*. A 27-year-old female patient appears with Redness and papular eruptions on both cheeks with mild burning and occasional pustules since 3 months.

The patient underwent individualized homeopathic treatment guided by detailed case-taking and constitutional analysis. Over three months, the patient demonstrated marked improvement in eruptions. This study highlights the potential of imponderabilia group of homeopathic medicine as a constitutional approach in management of disease.

Imponderabilia means which is not weighable, i.e. the substances which have no perceptible weights, they are immaterial power or energy; they may be natural or artificial. Medicines prepared from energy, available from natural and physical reactions are called imponderabilia.

Hahnemann observes in his organon, aphorism 280, footnote that, "even imponderable agencies can produce most violent medicinal effects upon man".

How a medicine can be prepared from the substance, which has no perceptible weight is a miracle of science of homeopathy. The immaterial power or any type of energy or any type of force (all can be understood in language of physics), have no perceptible weights. They cannot be estimated quantitatively. At the same time, they do not any form of but imponderables.

Homeopathy drugs prepared from any type of energies are known as imponderabilia. If we think of the matter in term of quantum physics, everything of this cosmos, even cosmos as a whole is nothing but a systematic pattern of energy. Energy can neither be created nor destroyed. - SL 6 pills TDS for 15 Days

2.3 Follow up

2.3.1 Date: 15/1/2025

- Burning and redness reduced by 50%. Pustules have dried.
- Patient feeling emotionally calmer.
- SL 6 pills TDS for 15 days

2.3.2 Date: 1/2/2025

- No new eruptions.
- Face almost clear.
- Patient sleeping better and less anxious before court cases.
- SL 6 pills TDS for 15 days

2.3.3 Date: 15/2/2025

- No new eruptions.
- Feeling of emotional well being and confident
- SL 6 pills TDS for 15 days

3. Results and Discussion

3.1 Results

The patient showed significant improvement over one month

- **Complete remission of acne lesions**, including pustules, papules, and comedones.
- **Marked improvement in skin texture and clarity**, with reduced post-acne pigmentation or scarring.
- **Improvement in general well-being**, including emotional state, confidence, and self-image.

3.2 Discussion

This case supports the potential of imponderabilia source homeopathy in managing Acne rosacea, complementing conventional approaches.
